### **Summary**

As a 310T Service Technician, you will be responsible for performing vehicle repair and maintenance work as assigned in accordance with dealer and factory standards.

- Valid G class driver's license with a good driving record.
- Must have necessary hand tools.
- Able to work effectively without supervision.

- Follow up with dispatch advisor regarding upcoming appointments and/or schedule changes.
- Perform inspections, diagnostic tests, troubleshooting and general vehicle repairs.
- Examine all vehicles to determine if additional safety or service work is required.
- Road test vehicles.
- Perform service calls and on-call duties on a rotational basis, and as required.
- Oversee the work of any Apprentice Technician assigned to you.
- Work in compliance with Company health and safety policies, OSHA and the Highway Traffic Act.
- Attend Company sponsored training classes and dealer specific training courses as scheduled by management.
- Other related duties as assigned.

### **Working Conditions**

The Technician will stand six to eight- and one-half hours (6-8.5 hours) per shift, lift parts weighing more than 50 pounds several times during each shift, and use hoist and test equipment as needed. They will stoop, kneel, crouch, crawl, reach, handle, and feel. They will use hand and power tools, and will be exposed to noise, vibration, dust, exhaust fumes, and other hazardous and non-hazardous materials. Road testing of vehicles may be required. The technician will be required to wear a company uniform at all times. They will also work outdoors regularly, in the elements, and must be dressed appropriately. The Technician is required to maintain a valid driver's license. If the Technician does not have a valid driver's license, they must advise their manager immediately and cease driving vehicles on behalf of the Company.
